PLEASE NOTE:

1. **Total green fees for the season must be received no later than the first night of league play.**
2. The committed number of weeks will be binding with additional dates assigned for rainouts.
3. Payment is to be made at the Gahanna Municipal Golf Course Pro Shop.
4. Checks must be made payable to the **City of Gahanna** (No two-party checks accepted).
5. **All monies are to be collected by the League Representative and presented to the Pro Shop at one time.**
6. Tee times will be assigned on a 10 minute rotation.
7. Leagues must start during their assigned tee times. – *If league starts late, tee times may be forfeited.*
8. All league players must check in for league play and retain receipts for carts purchased.
9. Substitute players should identify themselves as such when checking in for league play; *non-members substituting for members must pay full price.*
10. The Pro Shop must be notified in writing of permanent changes in players.
11. **All fees are nonrefundable.**
12. **All alcohol purchases must be done in the Pro shop. No carry on alcohol is permitted on the golf course. According to the State of Ohio Division of Commerce Department of Liquor Control it is unlawful to carry alcohol onto premises that obtain a current liquor license. The City of Gahanna holds a D1 beer only license for consumption on site and must be sealed for any carry out purchases. League members must abide by these rules or leagues may forfeit their time slot and no longer be able to play on the course.**
